## FINANCIAL RESPONSIBILITY AGREEMENT

### PAYMENT OF FEES/PROMISE TO PAY

I understand that when I register for any class at Warner University or receive any service from Warner University I accept full responsibility to pay all tuition, fees and other associated costs assessed as a result of my registration and/or receipt of services. I further understand and agree that my registration and acceptance of these terms constitutes a promissory note agreement (i.e., a financial obligation in the form of an educational loan as defined by the U.S. Bankruptcy Code at 11 U.S.C. §523(a)(8)) in which Warner University is providing me educational services, deferring some or all of my payment obligation for those services, and I promise to pay for all assessed tuition, fees and other associated costs by the published or assigned due date.

I understand and agree that if I drop or withdraw from some or all of the classes for which I register, I will be responsible for paying all or a portion of tuition and fees in accordance with the published tuition refund schedule. The tuition refund schedule is published within the University Catalog. I also understand that the withdrawing of classes may require a recalculation of federal and state aid. Furthermore, it is my responsibility to know the University's drop and withdrawal deadlines as stated on the Academic Calendar. It is also my responsibility to complete drop or withdrawal processes before the expiration of deadlines in order to terminate my enrollment without completion of my classes. My failure to drop or withdraw in a timely manner does not relieve me of my financial responsibility to Warner University for tuition and fees.

I understand if I am enrolled in classes and I do not attend, I am still responsible to pay the required tuition and fees if I fail to drop/withdraw by the designated dates.

I understand if my federal, state or sponsored aid is not received by the University, or if I lose my eligibility to retain financial aid for the semester, I assume personal responsibility for paying all student obligations.

I understand I am financially responsible and it is my responsibility to notify others (parent(s), spouse or other party) of my account balance. I understand I can authorize others to make payments or access my statement or financial information.

I have read the terms and conditions of the published tuition refund schedule and understand those terms are incorporated herein by reference. I further understand that my failure to attend class or receive a bill does not absolve me of my financial responsibility as described above.

### DELINQUENT ACCOUNT/COLLECTION

**Financial Hold:** I understand and agree that if I fail to pay my student account bill or any monies due and owed to Warner University by the scheduled due date, Warner University will place a financial hold on my student account, preventing me from registering for future classes, receiving my official transcripts, or diploma.

**Late Payment Charge:** I understand and agree that if I fail to pay my student account bill by scheduled due dates, Warner University will assess late payment and/or finance charges.

**Collection Agency/Attorney's Fees:** I understand and accept that if I fail to pay my student account bill by scheduled due dates, and/or fail to make acceptable payment arrangements to bring my account current, Warner University may refer my delinquent account to a collection agency or attorney for collection. I further understand that I am responsible for paying all costs and fees (including attorney's fees whether a lawsuit is filed or not) incurred by Warner University as a result of referral of my account to a collection agency or attorney for collection. Finally, I understand that my delinquent account may be reported to one or more credit bureaus.

## COMMUNICATION

**Method of Communication:** I understand and agree that Warner University uses my Warner e-mail as an official method of communication with me, and that therefore I am responsible for reading the e-mails I receive from Warner University on a timely basis.

**Contact:** I authorize Warner University and its agents and contractors, including collection agencies and/or attorneys under contract with Warner University, to contact me at my current and any future cellular phone number(s), email address (es) or wireless device(s) regarding my delinquent student account(s)/loan(s), any other debt I owe to Warner University, or to receive general information from Warner University.

**Updating Contact Information:** I understand and agree that I am responsible for keeping Warner University records up to date with my current physical addresses, email addresses, and phone numbers via my ROAR account and/or the Office of the Registrar.

## ENTIRE AGREEMENT

This agreement supersedes all prior understandings, representations, negotiations and correspondence between the student and Warner University, constitutes the entire agreement between the parties with respect to the matters described, and shall not be modified or affected by any course of dealing or course of performance. This agreement may be modified by Warner University if the modification is signed by me. Any modification is specifically limited to those policies and/or terms addressed in the modification.
